Item 3: Election of the Bureau

1. Three vacant seats are available in the Bureau following the resignation of Mr. Francis Ampe (France), Mr. Jacobo Pérez Lizaur (Mexico) and Mrs. Christabel Myers (United Kingdom).

- **Action required:** The Committee is requested to elect the Bureau among the proposals received from member countries.

Item 4: Reports by TDPC and Working Party Chairs

2. The Chair, will report on the latest developments since the 11th Session of the TDPC. The Chair will then brief delegates on the outcome of the *OECD World Forum on Key Indicators*, held in Palermo, Italy from 10-13 November 2004, where he participated as keynote speaker and made a presentation on the soft and hard use of indicators in regional development policies. He will also report on the outcome of the International Conference on *Knowledge Based Regional Development and Innovation*, which will take place in Florence, Italy on 25-26 November 2004.

3. Mr. Takayuki Hara, Chair of the Working Party on Territorial Policy in Urban Areas, will brief delegates on recent and ongoing activities. In particular, he will mention the organization of two important events to which all delegates are invited: an International Conference on *City Competitiveness*, kindly hosted by the Regional Government of the Canary Island in the City of Santa Cruz de Tenerife, Spain, due to be held on 3-4 March 2005; and an International Symposium on *Enhancing Cities' Attractiveness for the Future*, which will take place in Nagoya, Japan, 2/3 June 2005, kindly hosted by the Government of Japan,. The Secretariat will make a more detailed presentation of the event at the end of the meeting. The Symposium will be preceded by the 7th Session of the Working Party on Territorial Policy in Urban Areas on 1 June.

4. Mrs. Margaret Clark, Chair of the Working Party on Territorial Policy in Rural Areas will report on past and ongoing activities, in particular, the outcome of the conference on the *Future of Rural Policy* held in March 2004 in Warrenton, Virginia, near Washington (USA), and on the preparation of the rural policy conference in Oaxaca, Mexico, scheduled in April 2005. She will also report on the outcome of the Working Party's 6th Session on 7 December.

5. Mr. Ray Bollman, Chair of the Working Party on Territorial Indicators will report on the latest developments within the Working Party and in particular will brief the Committee on the group's contribution to the preparation of *The Symposium on Diagnosing Regional Competitive Advantage*, which will be held in June 2005.

Item 5: Introductory Remarks and Presentations by the Director of GOV and TDPC Chair

6. Fabrizio Barca, Chair will make introductory remarks on the agenda items of the two-day meeting. This will be followed by a presentation by Odile Sallard, Director of GOV, on the latest developments in the Directorate and in particular on two documents prepared by the Secretariat further to the Committee's discussion on the programme of work 2005/6 at its 11th Session [GOV/TDPC(2004)3FIN]:

1. **The TDPC Communication Plan** aims to increase the visibility of TDPC work in its role as the first international forum for discussion on regional policy. The Secretariat will present a draft paper outlining current procedures and several proposals on how to enhance communications with the resources available. The Committee is required to provide guidance to the Secretariat on how to develop of an effective communication strategy.
2. **The Proposed Draft Strategy for Defining the Role and Participation of Non-Members in the TDPC's Work** fits into the OECD's new Enlargement and Outreach Strategy, (see revision of the Resolution of the Council on the participation of non-Members in the work of subsidiary bodies of the Organisation C(2004)132).

Item 6: OECD Regions at a Glance

7. The Secretariat will present the manuscript of the forthcoming publication "OECD Regions at a Glance", the first in a series of biennial publications. It illustrates, analyses and compares major territorial patterns and regional trends across OECD member countries. On the one hand it shows how territorial indicators are used for the design and assessment of territorial development policies within the policy framework elaborated by the TDPC. On the other it aims to diffuse the statistical tools elaborated by the Working Party on Territorial Indicators for the analysis of regional economies.

Item 7: National Territorial Review of Japan

8. The National Territorial Review of Japan and its assessment and recommendations will be introduced by representatives from the Japanese authorities and the Secretariat. In addition, peer reviewers, Mr. Paul LeBlanc (Canada) and Ms. Maike Richter (Germany), will provide comments on the Review. The Review focuses on the evolution of territorial policies in Japan, notably in the fields of territorial planning, regional industrial policy, urban policy and rural development, and the significance of this reform process for achieving national policy goals such as sustaining economic growth, addressing population aging and reshaping relations between levels of government..

Item 8: Building Competitive Regions: Strategies and Governance

9. The Secretariat will present the manuscript for the forthcoming publication . It consists of two parts on: 1) regional competitiveness and 2) governance strategies. It will be accompanied by a brief note on the main issues for discussion. It incorporates the findings from the territorial reviews at regional level and peer reviews and a survey of the economic literature. It incorporates analyses on both urban and rural areas as well as the conclusions of the TDPC Symposium on Innovative Institutional Mechanisms for Territorial Development, held in June 2004.

Item 9: Metropolitan Review: The Case of Busan, Korea

10. This study will examine how Busan, the second city of Korea and fifth container port in the world, can benefit from the two priority issues on the national policy agenda: balanced development across regions and decentralisation. Integrated cluster policies and local capacity-building will be crucial to raise the region's international competitiveness and upgrade its governance mechanisms. The report and its assessment and recommendations will be introduced by Mr. O-Kyu Kwon, Ambassador of the Permanent Delegation of Korea to the OECD and representatives of the Busan Metropolitan City Government, followed by a presentation by the Secretariat.

Item 10: Draft Agenda of the Symposium: Diagnosing the Competitiveness of Regions

11. At its 11th Session in June 2004 the Committee organised a symposium on "Innovative Institutional Mechanisms for Territorial Development". The format received a very positive response from delegates from the Committee, which decided to hold an annual symposium-style session the first day of each TDPC spring meeting. Following the suggestion of the United States for the next symposium-style session to focus on diagnosing regional competitive advantage the Secretariat will present a draft outline of the *Symposium : Diagnosing the Competitiveness of Regions*, which will be held in June 2005.

Item 11: Enhancing the Contribution of Higher Education Institutions to Regional Development: Issues paper

12. The Secretariat will introduce the joint activity undertaken by GOV and the Education Directorate (EDU) on *Enhancing the Contribution of Higher Education Institutions to Regional Development*. Delegates are requested to provide their views and guidance on the proposed methodology and approach for this activity in co-operation with the Directorate for Education.
