- Apr. 9 Kyoung-Ryung Seong is inaugurated as the first chairman of the committee
- Dec. 29 Enact the Special Act for Balanced National Development (Act 7061)

- Jan. 16 Publicize the Special Act for Balanced National Development
- Mar. 29 Publicize the Enforcement Ordinance of the Special Act for Balanced National Development (Presidential Order 18346)
- Apr. 1 Implement the Special Act for Balanced National Development and the Enforcement Ordinance  
The Presidential Committee on Balanced National Development is reborn as a legal entity  
Chairman Kyoung-Ryung Seong remains in office
- May 3 Set up and organize the committee for evaluating balanced national development projects
- May 6 Organize the special committee for transferring public institutions to local areas
- Aug. 26 Finalize and implement the first 5-year plan for balanced national development

- Jan. 1 Implement the special accounting for balanced national development
- Mar. 30 Establish the National Educational Institute for Regional Innovation
- Mar. 30 Set up the regional innovation cluster policy coordination committee

## Organization

- ▶ **The Presidential Committee on Balanced National Development** (Special Act, Article 23)
  - The committee is composed of government (12 Ministries) and civilian members.
  - The committee consists of fewer than 30 members including the chairman.
  - ※ Related Ministries : The Ministry of Finance and Economy, The Ministry of Education and Human Resources Development, The Ministry of Science and Technology, The Ministry of Government Administration and Home Affairs, The Ministry of Culture and Tourism, The Ministry of Agriculture and Forestry, The Ministry of Commerce, Industry, and Energy, The Ministry of Information and Communication, The Ministry of Environment, The Ministry of Construction & Transportation, The Ministry of Maritime Affairs and Fisheries, The Ministry of Planning and Budget
- ▶ **The Special Committee** (Enforcement Ordinance, Article 24)
  - The committee is composed of government bureau heads and civilian experts.
  - Research and review the issues which the committee will deal with, by area in advance.
- ▶ **Evaluation Committee** (Enforcement Ordinance, Article 13)
  - The committee consists of members who have sufficient knowledge and experiences in balanced national development.
  - Evaluate the performance of balanced development plans devised by local governments and Ministries.
- ▶ **Advisors** (Enforcement Ordinance, Article 2)
  - The number of advisors not to exceed 200, providing advice regarding committee management.
- ▶ **The Regional Innovation Cluster Policy Coordination Committee** (Detailed Committee Management Regulations, Article 24)
  - Composed of Deputy Ministers (related Ministries) and experts (fewer than 20) who have enough knowledge and experiences in clusters.
  - ※ Related Ministries : The Ministry of Education & Human Resources Development, The Ministry of Science and Technology, The Ministry of Culture and Tourism, The Ministry of Agriculture and Forestry, The Ministry of Commerce, Industry, and Energy, The Ministry of Information and Communication, The Ministry of Health and Welfare, The Ministry of Labor, The Ministry of Planning & Budget, The Korean Intellectual Property Office
- ▶ **The Balanced National Development Planning Division** (Special Act, Article 26)
  - The Management Offices of the Committee

Adjust and review key matters regarding  
balanced national development.

## The Functions of the Committee

- An advisory committee for the President, which was set up to provide him with relevant information, with regard to key policies for efficient implementation of balanced national development
- Adjustment of key issues regarding balanced national development and review of balanced national development plans
- Evaluation of the performance and budget of balanced national development projects

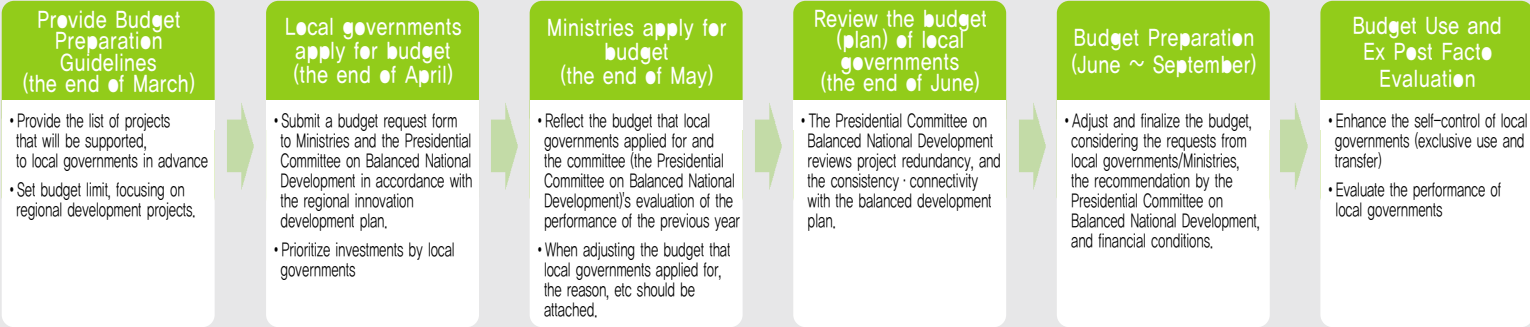


# The Special Accounting for Balanced National Development

- Objective
  - Provide financial assistance to various balanced national development projects implemented by Central Ministries systematically through a special accounting system
  - Guarantee Efficiency and Propriety in Time and Size of Projects
- Size – About 5.5 trillion won (2005) ※ It's expected to increase 8.5% annually on average and to be 7.5 trillion won in 2009
