- 농·어가자산 중 토지자산을 평가함에 있어 종전에는 조사담당자가 직접 조사하여 평가하였으나, 1999년부터 공시지가를 적용하는 것으로 변경하였음.
- 농가의 주·부업 구분은 2003년부터 세분하고 있으며, 주업농가에서 전문 및 일반농가의 정의는 농업조사와 동일함.
- 2009년 조사부터는 COICOP분류체계에 따라 자산이전수입 및 자산이전지출을 집계에서 제외함.

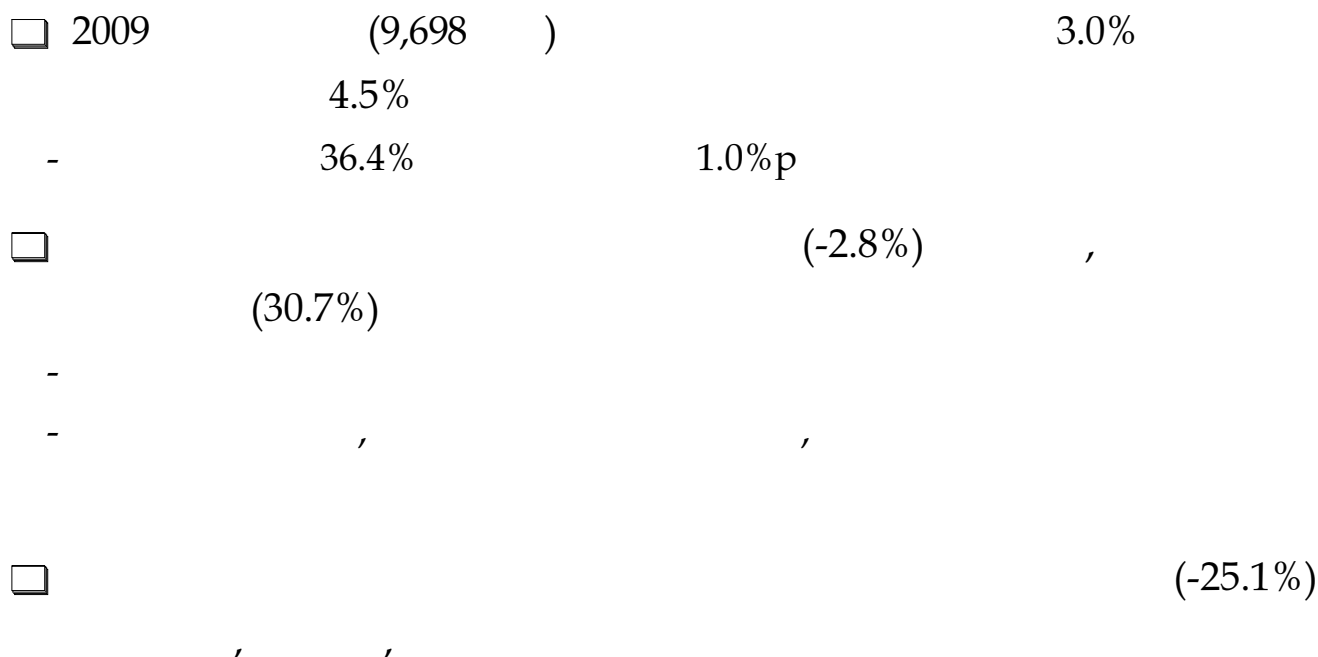

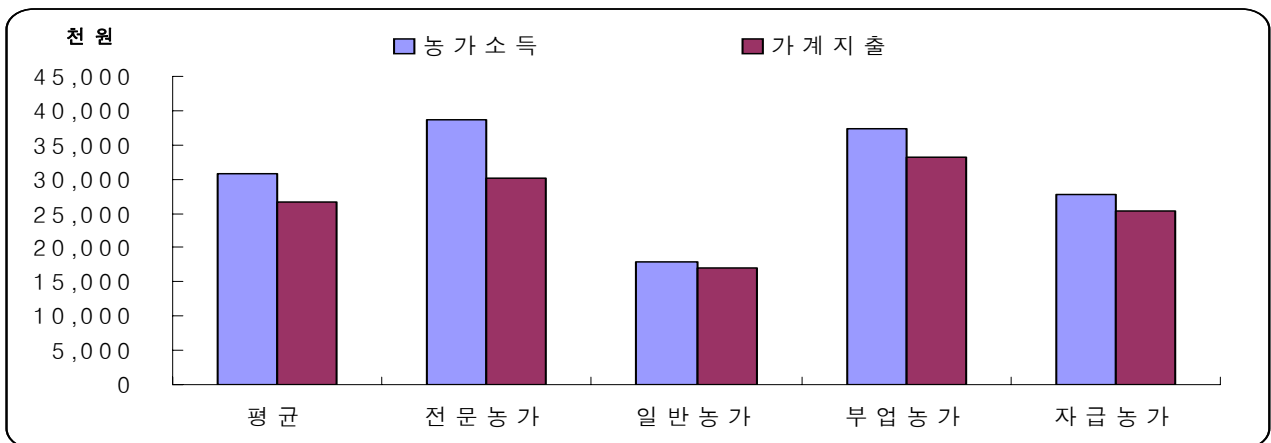

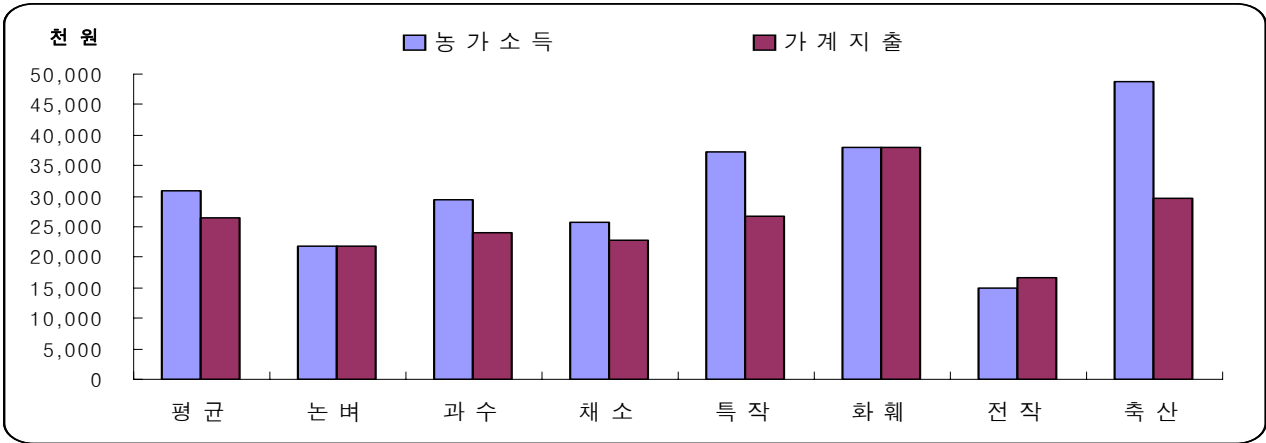

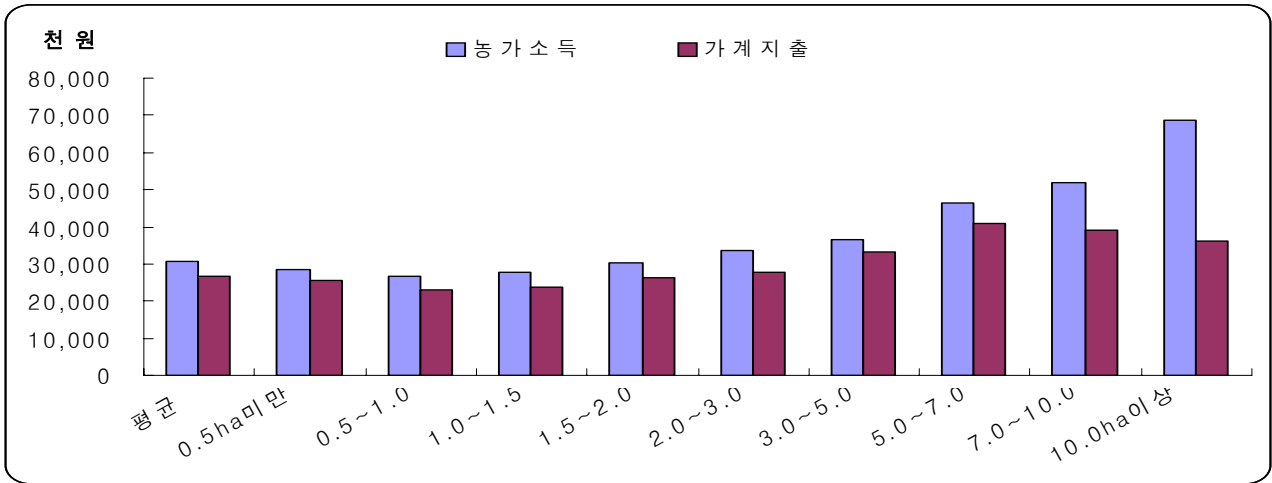

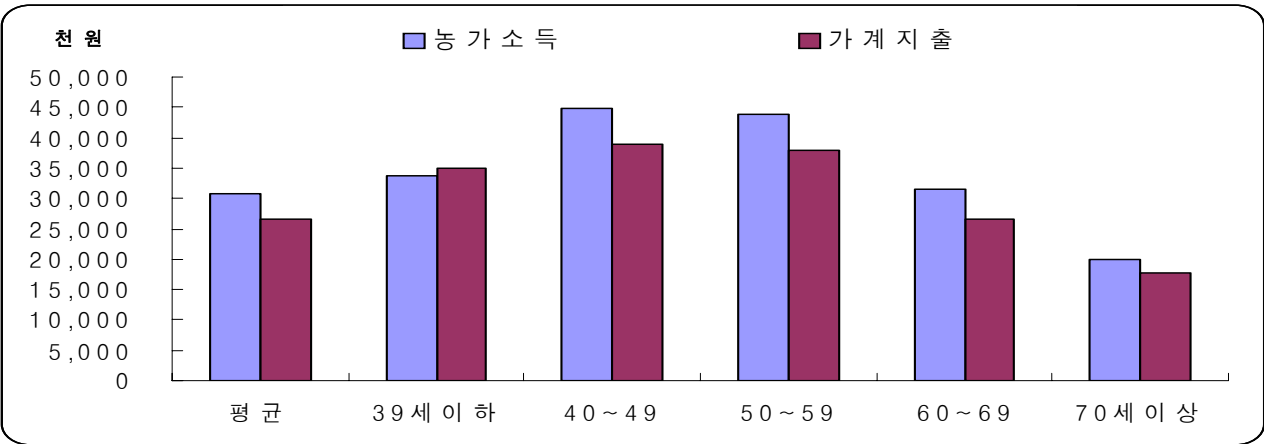

<그림 6> 경영주연령별

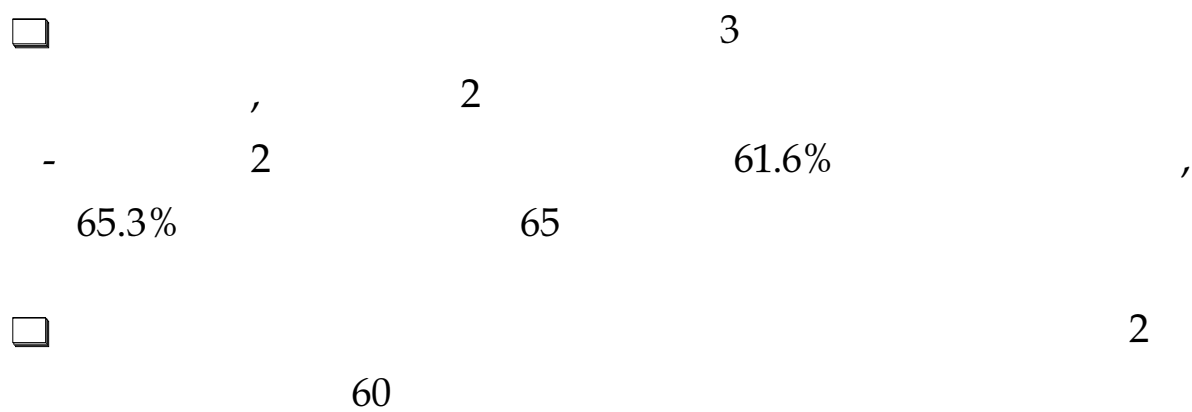

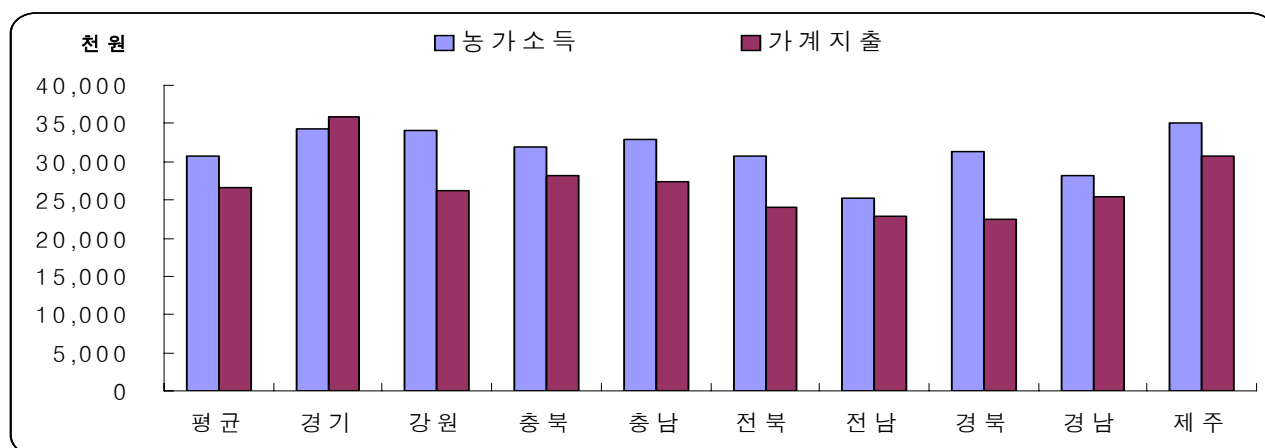

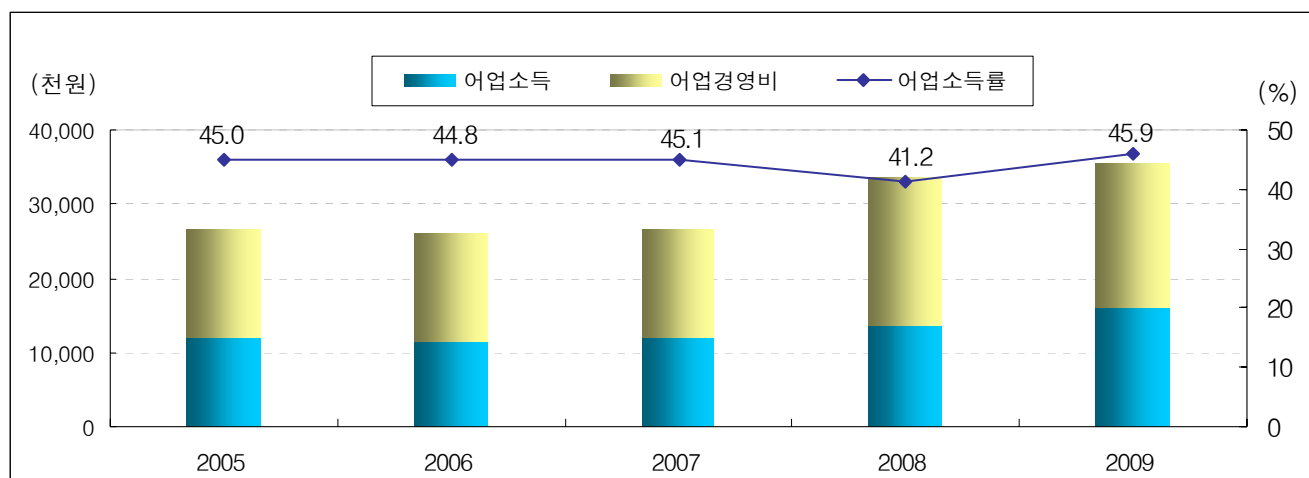

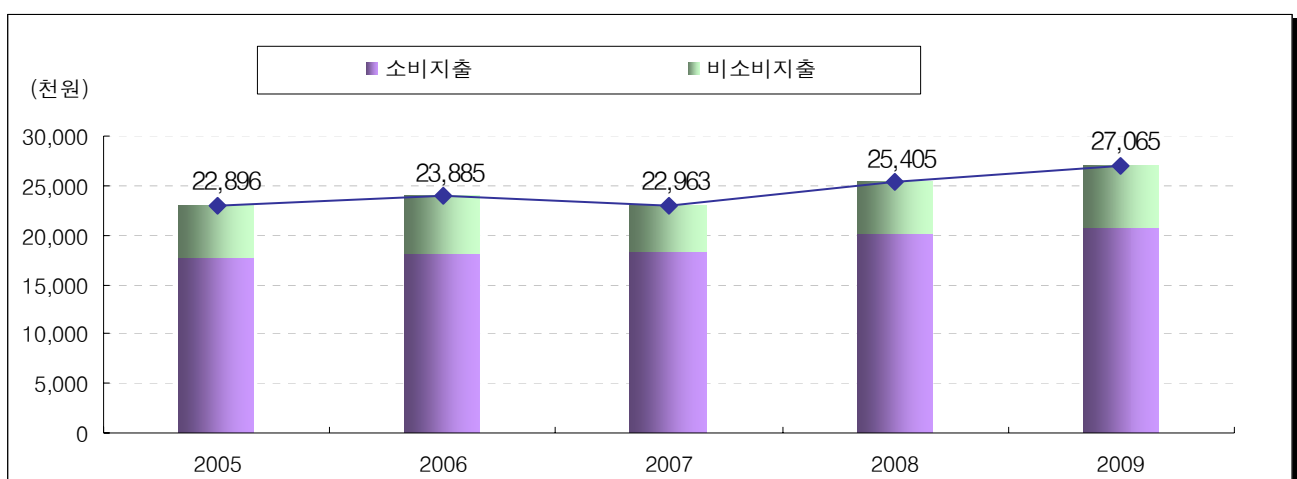

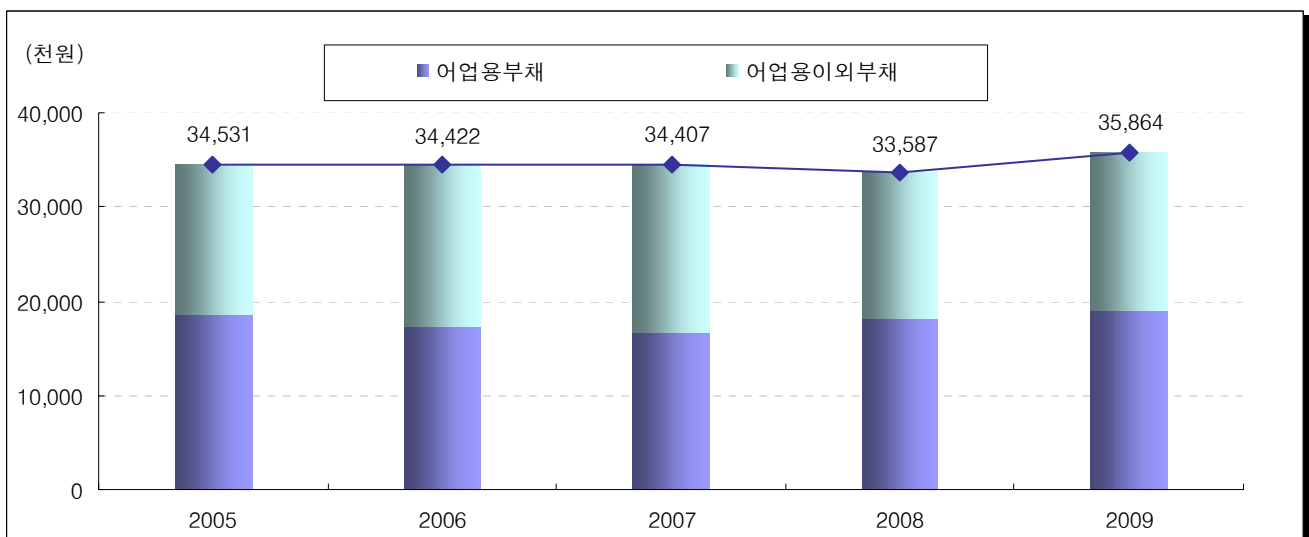

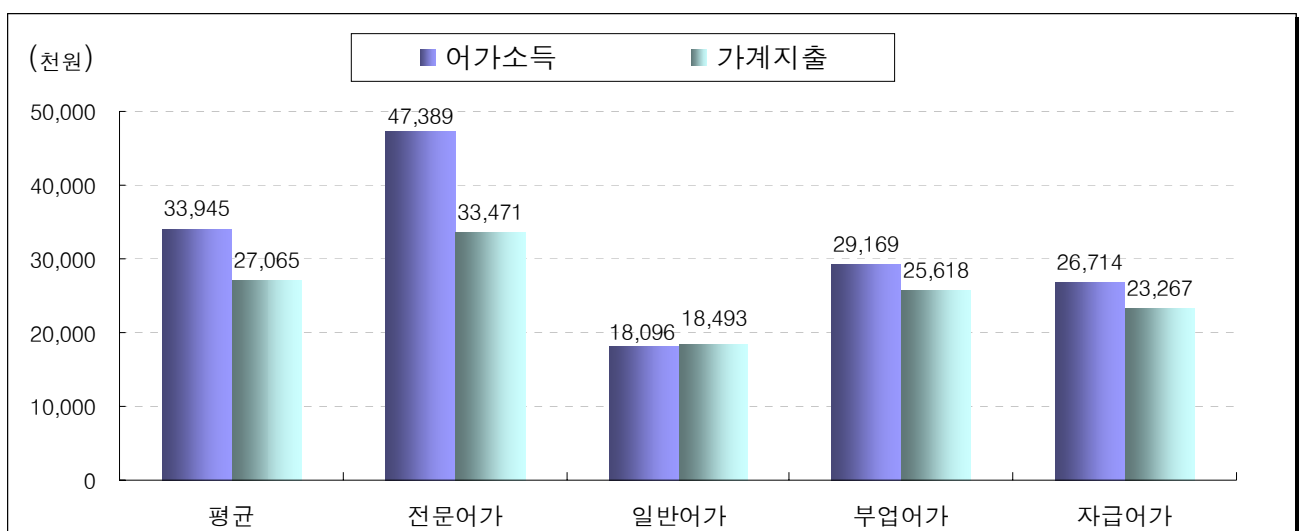

< 그림 6 > 주·부업별 어가소득



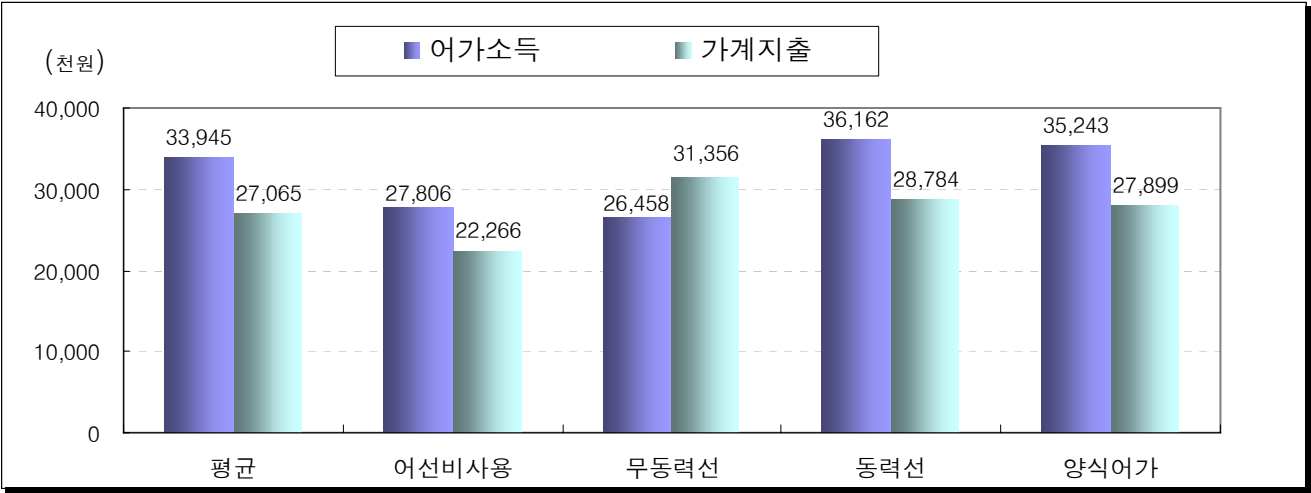

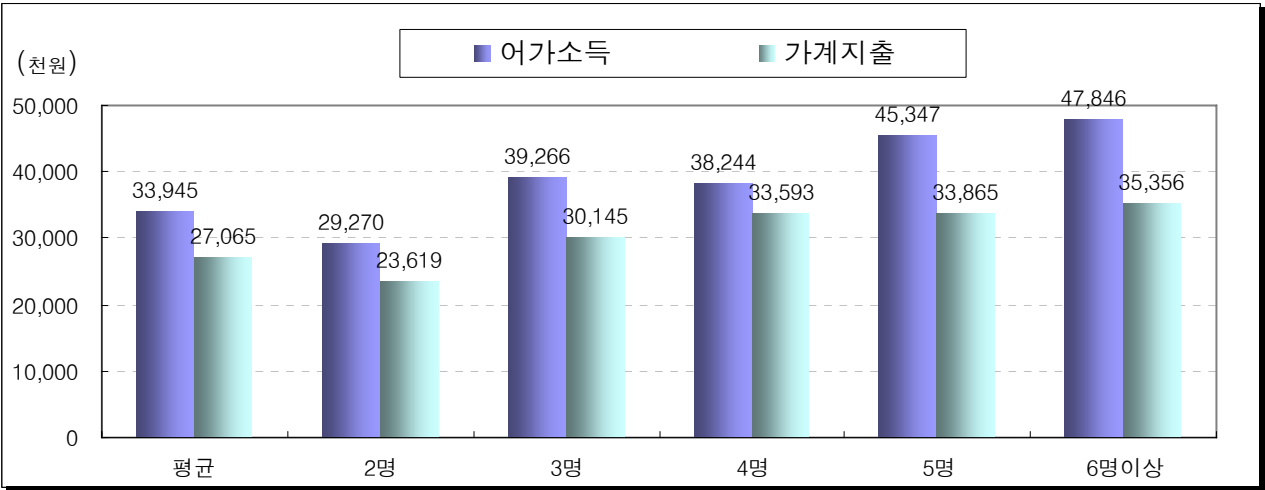
